2. That temporary quarters be rented in the Kowloon now territories for our South China Union Training Institute work, and that plans for the building of the new school site be pushed forward.

- 3 That P. E. Quimby and family, and Li Ming Ih of Chiao Tou Tsong be assigned to assist in the work of the South China Union Training Institute; F. A. Landis and family, Ho Ping Dwan, and Meng Djung I of Chiao Tou Tseng assist in the work of the Yencheng Training Institution, and C. L. Blandford assist in the work of the Home Study Institute in Hongkong. Thus the educational work to be done in all these places may be strongthened in this time of national emergency.
- 4. That an emergency appropriation of \$3,000 Hongkong currency be made to help moot the special expense of temporarily locating the South China Union Training Institution in the new territories. (p.1056-57)

He spoke of the faithfulness of the departmental leaders carrying on as they have under present conditions. While the results in soul saving have not been as large as it was hoped they would be, yet God has led by 437 being baptized. Had the results been as good as the Ingathering receipts there would have been a large ingathering of souls. Mention was made of how the General Conference has responded by granting appropriations for the needs in this field. Truly we have much for which to be thankful. (p.4-5)

NSD EDUCATION AND ENGLISH LANGUAGE SCHOOLS DEPARTMENT REPORT FOR NSD ANNUAL COUNCIL

OCTOBER 31-NOVEMBER 3, 2008

Chinese Union Mission (CHUM) has been facing the pressures of changing trends resulting in the closure of 2 schools (Hong Kong Sam Yuk Secondary School [HKSYSS] on Hong Kong island, and Sam Yuk Middle School [SYMS] located on the same campus as Hong Kong Adventist College [HKAC]), which were funded by the HK government. However, the Union and the College have seized the opportunity to reinvent a form of education that refocuses on providing Adventist Christian Education on the campus of Hong Kong Adventist College to their constituency. It is called a "through-train" education system. The newest institution is the Hong Kong Adventist Academy (HKAA) and it was surveyed by a team from the Northern Asia-Pacific Division Commission on Accreditation (NSDCA) from September 7-9. The survey team recommended that it be granted candidacy status through the NSDCA to the Accrediting Association of Seventh-day Adventist Schools, Colleges, and Universities (AAA) for 2 years with annual reports to the Union and Division Education Departments. It is like starting Adventist Education all over again but keeping true to its name by having 100% Adventist faculty for all the institutions within that campus so that the mission emphasis can appropriately realized.
